"I was the original complainant in FIR bearing No. 131/2024 dated 11.11.2024 registered by EOW, New Delhi. On basis of the said FIR, Enforcement Directorate had registered an ECIR bearing ECIR/STF/14/2025 dated 16.06.2025 wherein I have been arrested on 10.10.2025.

Therefore, in light of the same, I am tendering my resignation as Executive Director and CFO of Reliance Power Limited with effect from 11.10.2025 considering the pendency of investigation.

I have informed the same to my counsel Mr. Yash Agrawal on 11.10.2025 when he had met me and I have further communicated to him that I will tender a formal letter of resignation on 13.10.2025 resigning from the said post with effect from 11.10.2025.

I state that I maintain my innocence and I am not involved in any wrong doing, however, I am tendering my resignation considering my arrest and pending investigation in the interim till my name is cleared."
