Report on Postal Ballot

This has reference to my appointment as Scrutinizer by the Board of Directors of the Company at their meeting held on July 18, 2014 in terms of Section 110 of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014, for voting by Electronic means and Postal Ballots received, in respect the Notice dated August 18, 2014 issued by Reliance Power Limited (the Company) to all the shareholders of the Company.

The Voting by electronic means was validated with software controls.
