- The 45 MW wind project in Vashpet, Maharashtra Operated at a high PLF of 33%

Capacities under Construction

- The progress at the second Unit of 660 MW of Sasan UMPP of 3960MW is on track and the Unit is likely to be commissioned in November 2013. The work at 100 MW Concentrated Solar Power (CSP) project in Dhursar, Rajasthan is on stream and the project is expected to be commissioned in the current financial year.
